

School Parent & Family Engagement Policy Apollo Junior High 2025-2026

Part I: General Expectations

The Apollo Junior High agrees to implement the following statutory requirements:

 - FOCUS internet access to student grades
- 5. At the request of parents, the Apollo JH will provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about their children's education. The school will respond to any such suggestions as soon as practicably possible by:
 - Follow up in the next meeting
 - Letter, phone call, or email
- 6. The Apollo JH will provide each parent with an individual student report about the performance of their child on the State assessment in at least math, language arts, and reading by:
 - Parents will receive their student's STAAR test results, and a letter of explanation
- 7. The Apollo JH will assist parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below --
 - the state's academic content standards,
 - The state's student academic achievement standards,
 - the state and local academic assessments, including alternate assessments,
 - the requirements of Part A,
 - How to monitor their child's progress, and
 - How to work with educators:
