

## 2022-2023 School Parent & Family Engagement Policy

To develop a partnership with parents/legal guardians and ensure student achievement of the state's high academic standards, Audelia Creek Elementary will:

- Involve parents/legal guardians in the school's parental involvement policy review and enhancement in an organized, ongoing, and timely manner. • Involve parents/legal guardians in school-wide program planning and development in an organized, ongoing, and timely manner.
- Hold an annual informational meeting for parents/legal guardians on the school's Title I, Part A programs participation, requirements, and parental rights.
  - The school will offer several meeting opportunities at convenient times.
  - The school will invite all parents/legal guardians of students participating in Title I, Part A programs.
- Provide information about Title I, Part A programs to parents/legal guardians of participating students in a timely manner.

- Recommend to the Local Educational Agency (LEA) parents/legal guardians of participating students of Title I, Part A programs interested in serving on the State's Committee of Practitioners and School Support Teams.
- Work with the LEA in addressing problems, if any, on parental involvement activities implementation in section 1118 of Title I, Part A.

- Work with the LEA to ensure that a copy of the SEA's written complaint procedures for resolving any issue of violation(s) of a Federal statute or regulation of Title I, Part A programs is provided to parents/legal guardians of students and to appropriate private school officials or representatives.
