

# **Math Science Technology Magnet Parental and Family Engagement Policy**

**2022-2023**

## **PART I. GENERAL EXPECTATIONS**

MST agrees to implement the following statutory requirements:

(1) Consistent with section 1118, the school will work to ensure that the required school level parental and family engagement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

*(D) the carrying out of other activities, such as those described in section 1118 of the ESEA.*

## **PART II. DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL PARENTAL AND FAMILY ENGAGEMENT POLICY COMPONENTS**

(1) MST will involve parents in the joint development of its school parental and family engagement plan under section 1118 of the ESEA.

(A) Invitations to all Local School Council meetings via school letter and Facebook

(2) MST will involve parents in the process of school review and improvement under section 1116 of the ESEA.

(A) Invitations to Local School Council meetings via school letter, Facebook and the Parent Newsletter

(3) MST will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental and family engagement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children

participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:

(A) Meet the Teacher Night- August

(B) Providing a special activity for the class with the most parents in attendance

(C) Provide class incentives for those students whose parents attended

- (4) MST will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet.
  - (A) Information will be presented at Meet the Teacher
  - (B) Those who cannot attend will get the information in writing via email, website, and or newsletter.
  
- (5) MST will at the request of parents, provide opportunities for regular
  - (A) meetings for parents to formulate suggestions and to participate, as appropriate, in
  - (B) decisions about the education of their children. The school will respond to any such
  - (C) suggestions as soon as practicably possible.
  - (D) Emails or phone calls
  - (E) Activities offered after each PTA meeting
- (6) MST will provide each parent an individual student report about the performance of their child on the State assessment in at least math and reading.
  - (A) Providing information on how to log in to the system
  - (B) Announcing/discussing the school's report card at an annual meeting
  
- (7) MST will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56f the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002).
  - (A) Letters from the principal will be sent home to the necessary students.
  
- (8) MST will assist parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph:
  - (A) the state's academic content standards,
  - (B) the state's student academic achievement standards,
  - (C) the state and local academic assessments including alternate assessments,
  - (D) the requirements of Part A,
  - (E) how to monitor their child's progress, and
  - (F) how to work with educator
  
- (9) MST will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement.
  - (A) Family Engagement Nights
  - (B) Parenting Tips Website

(10) MST will educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools.

(11) MST will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand.
