# Richland Elementary School Parent & Family Engagement Policy 2025-2026

### PART I. GENERAL EXPECTATIONS

Richland Elementary agrees to implement the following statutory requirements:

- Consistent with Section 1116, the school will work to ensure that the required school-level parent & family

#### PART II. IMPLEMENTATION OF SCHOOL-WIDE PARENTAL & FAMILY ENGAGEMENT POLICY COMPONENTS

  academic assessment used to measure children's progress, and the proficiency levels students are expected to
  meet by:
- Discussing this info at curriculum night(s), STAAR informational meeting night(s), and the annual Title I meeting
- Richland Elementary will, at the request of parents/guardians, provide opportunities for regular meetings for
  parents/guardians to formulate suggestions and to participate, as appropriate, in decisions about the education of
  their children. The school will respond to any such suggestions as soon as practicably possible by:
- Scheduling follow-up meetings with parents/guardians to determine how to incorporate their suggestions
- Providing opportunities for suggestions and responding to them at PTA meetings
- Holding breakfast/coffee, lunch and learn, or evening meetings
- Richland Elementary will provide each parent/guardian an individual student report about the performance of his/her child on the State assessment in at least math, language arts, and reading by:

  - Richland Elementary will assist parents/guardians of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph— o Holding an annual Title I meeting, parent/teacher conferences, and/or curriculum nights/meetings to inform parents/guardians about: the state's academic content standards
  - o the state's student academic achievement standards
  - o the state and local academic assessments including alternate assessments
  - o the requirements of Part A
  - o how to monitor their child's progress
  - how to work with educators
  - Richland Elementary will provide materials and training to help parents/guardians work with their children
    to improve their children's academic achievement, such as literacy training and using technology, as
    appropriate, to foster parent & family engagement by:
  - PTA meetings
  - Parent/Teacher conferences
  - o Open House
  - o STEM Night
  - Literacy Night
  - Family events (Pastries with Parents, Donuts with Dads, Muffins with Moms, etc.)
  - Richland Elementary will, with the assistance of its parents/guardians, educate its teachers, student services personnel, principals, and other staff in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents/guardians, and in how to implement and coordinate parent programs and build ties between parents and schools by:
  - Sharing information about community events & encouraging staff to participate o Night at the Movies,
