Skyview Elementary Parent and Family Engagement Policy

PART I. GENERAL EXPECTATIONS

Skyview Elementary agrees to implement the following statutory requirements:

Skyview Elementary will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- 6. Skyview Elementary will provide each parent an individual student report about the performance of their child on the State assessment in at least math and reading by:
 - Parents will receive a letter on how to access their student's STAAR test results online.

- 7. Skyview Elementary will aid parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph:
 - the state's academic content standards
 - the state's student academic achievement
 - · the state and local academic assessments including alternate assessments

 - · how to monitor their child's progress
 - · how to partner with teachers and staff members
